#### Adoption of the 2024/25 Budget

#### **RESOLUTION 24-03**

Upon motion of Mayor Weinberg, seconded by Deputy Mayor Weston, and unanimously approved, the following resolution was adopted:

RESOLVED, that the Budget of the Village of Thomaston for the fiscal year March 1, 2024 through February 28, 2025, in the form attached to these minutes, is hereby approved and adopted, and that the several amounts set forth therein be and hereby are apportioned for the objects and purposes specified, and that the schedule of salaries and wages attached to such budget shall be the maximum salaries to be paid, and it is further

RESOLVED, that a general tax rate of \$33.481 per \$100 assessed valuation is and the same is hereby levied on all real property within the Village of Thomaston, and it is further;

WHEREAS, that portion of the Village of Thomaston which is north of the Long Island Railroad Co. property lies outside of the Manhasset-Lakeville Fire and Water District, and no services are rendered by said Fire and Water District in said portion of the Village of Thomaston north of the LIRR property, and no taxes for such services are levied by the Town of North Hempstead against the real property located in said northerly portion of the Village of Thomaston,

#### NOW THEREFORE,

BE IT RESOLVED, that an additional tax rate of \$17.277 per \$100 assessed valuation be and the same hereby is levied on all real property within the Village of Thomaston north of the Long Island Rail Road Co. property as it appears on the assessment roll for 2024/25 for the protection of persons and property, said protection to be provided by Vigilant Engine and Hook and Ladder Co. by contract with the Village of Thomaston. The cost of such services shall be equal to the amount raised by the additional tax rate of \$17.277 per \$100 assessed valuation, inclusive of such insurance premium as the Village of Thomaston shall be required to pay pursuant to the Volunteer Firefighters' Benefit Laws of the State of New York, as amended.

#### Road, Drainage and Sidewalk Improvements 2023-01

#### **RESOLUTION 24-08**

Upon motion of Trustee Sherman, seconded by Trustee Chagrin, and unanimously approved, the following resolution was adopted:

WHEREAS, the Village of Thomaston heretofore entered into an agreement with John McGowan & Sons, Inc. ("McGowan"), for the performance of certain public works identified as "Road Drainage and Sidewalk Improvements - Bid 2023-01", and

WHEREAS, during the performance of such contract work by McGowan, various unanticipated conditions were discovered, by reason of which certain extra work, labor and materials were required to effectuate the contract purposes, and certain work, labor and materials required by the contract were no longer necessary or appropriate, and

WHEREAS, in particular, when sidewalk panels were lifted, it became apparent that utilizing concrete to ramp the resulting height differential would create tripping hazards, and cutting of tree roots exposed by lifting the panels might have made trees unstable and damaged the habit of the trees, and

WHEREAS, it was determined, and agreed, by the Village and McGowan that replacement of more sidewalk panels than originally anticipated, by eliminating some concrete ramping and utilizing greater quantities of concrete than originally contemplated, and without cutting of tree roots and/or removal of trees, was more desirable to effectuate the purposes of the public work under contract, and

WHEREAS, the foregoing changes in the scope of work, labor and services resulted in an additional cost of \$86,176.50 for work, labor and services for extra sidewalk replacement, and additional costs of \$4,400.00 for extra labor to excavate around trees, and

WHEREAS, the foregoing changes in the scope of work, labor and services also resulted in credits to the Village in the amount of \$20,000.00 for concrete ramping work which was no longer necessary, and was not performed, and in the amount of \$16,176.50 for other work, labor and services which had become unnecessary, and

WHEREAS, the net additional cost to the Village for the foregoing agreed extra work, labor and services, and changes in the scope of work, labor and services, is \$54,400.00, for which the Village has received McGowan Invoice 11318, dated December 20, 2023,

### NOW, THEREFORE, BE IT

RESOLVED, that the Board of Trustees of the Village of Thomaston has reviewed McGowan invoice 11318, dated December 20, 2023, in the amount of \$54,400.00, and hereby approves and authorizes payment of the aforesaid invoice in such amount.

#### Lights in the Right-of-Way

Mayor Weinberg updated the Board regarding their prior discussion at the December 11, 2023 to consider the possibility of allowing residents to request permission to display holiday lights on trees in the Village right-of-way. After discussion, the Board consensus was that establishing a procedure for private use of property in the Village right-of-way, even on a temporary

or limited basis, may raise other issues or requests, and therefore, it may be best for the Village not to establish a procedure to allow for temporary or limited use of the Village right of way at this time.

Mayor Weinberg informed the Board that the DPW single bay garage door, located at the south end of the parking lot, is in need of replacement. The Board reviewed four (4) quotations the replacement of the garage door, in compliance with the Village procurement policy.

## **Tax Warrant**

You are hereby commanded to receive and collect from the several persons named in the assessment roll, hereunto annexed, the several sums named in the last column thereof opposite their respective names, for the following purposes:

Upon the receipt of the roll and warrant by you and on or before the first day of March, 2024, you shall cause to be published in the official paper of the Village, once a week for two consecutive weeks, a notice that such tax roll and warrant have been left with you for the collection of taxes therein levied, and shall designate one or more convenient places in the Village where you will receive taxes from March first, 2024, to and including March thirty-first, 2024, from nine o'clock in the morning until four o'clock in the afternoon, except Saturdays, Sundays, and holidays;

For said period of time you will receive all taxes paid to you without additional charge;

On such taxes remaining unpaid after March thirty-first, 2024, interest of five percentum shall be added for the month of April or fraction thereof and an additional one percentum for each month or fraction thereof thereafter until paid.

You shall attend at a time and place specified in said notice for the purpose of receiving said taxes;

After the thirty-first day of March, 2024, you shall proceed to collect the taxes remaining unpaid, with interest as herein provided, but without any other fee or charge, and for that purpose you are possessed of all the powers of a town tax collector.

All interest collected shall belong to the Village.

You are to make a return of this warrant on or before the first day of November after the delivery thereof to you, showing the total amount of taxes paid and each tax unpaid, with a receipt of the village treasurer for all taxes paid to him or her, and shall file the roll and warrant in the office of the village administrator.

And so for doing this shall be your sufficient warrant.
