Review Design Review Board Recommendations

Application to install solar panels at the existing single-family dwelling at 4 N. Avalon Road.

Kevin Orlando, Long Island Power Solutions (contractor) was present to answer any questions. Mr. Hom, property owner was also present. This application was previously considered by the Board on March 13, 2023 but the motion did not receive affirmative votes of a majority of the whole Board, and was not adopted. The Board considered the following aspects of the application: The "L" shaped array of the solar panels on the front roof is partially hidden by the dormers and elevation of the roof; removal of the "L" shape panels would result in insufficient power generation; the is no visual impact to the homeowner opposite 4 N. Avalon Road as that home faces Schenck Avenue; no neighbors expressed opposition to the application at any of the Design Review Board meetings.
