DAY AFTER THANKSGIVING

CHRISTMAS DAY - December 25

In the event a holiday falls upon a Sunday, the following Monday shall be deemed to be the legal holiday. In the event the legal holiday falls on a Saturday, the preceding Friday shall be deemed to be the legal holiday.

When a holiday falls within a period of paid leave, the holiday shall not be counted as a leave day in computing the amount of leave debited.

A full-time non-union employee who is absent without leave on the day immediately preceding or following a holiday shall lose the holiday as well as pay for that day.

Non-exempt full-time non-union employees required to work on any designated holiday shall receive double time rate of pay.

Part-time non-union employees are not eligible for holiday pay."
