MINUTES OF A REGULAR MEETING OF THE BOARD OF TRUSTEES OF THE VILLAGE OF THOMASTON October 11, 2023

The Board of Trustees met on Wednesday, October 11, 2023 at the Village Hall, 100 East Shore Road, Great Neck, New York at 7:30 p.m.

The Mayor opened the meeting at 7:53 p.m.

Mayor Weinberg the following brief statement (paraphrased):

We stand with Israel, our solidarity is with Israel and I'm sure not only on behalf of the Village but on the half of any human being, we will certainly do anything humanly possible that we can to support or help in any way, shape, form or manor. I'm sure there will be communication about donation drives and events about standing in solidarity with Israel. We will continue to post the information on the Village website so that people can have a way of showing and demonstrating their sorrow and their support for these horrific events. With that in mind, I would like to propose the following resolution:

RESOLUTION 23-79

Upon motion of Mayor Weinberg, seconded by Trustee Halpern, and unanimously approved, the following resolution was adopted:

WHEREAS, on October 7, 2023, Hamas terrorists launched a coordinated, unprovoked attack on Israel from the Gaza Strip; and

WHEREAS, Hamas has fired thousands of rockets toward Israel's major population centers, breached Israel's borders, infiltrated Israeli communities and kidnapped over 150 civilians from numerous nations, killed and massacred more than 1,200 Israelis, and wounded over three thousand more; and

WHEREAS, twenty-two (22) Americans have been declared dead at the hands of Hamas; and

WHEREAS, this is the most significant, horrific attack on Israel since the Yom Kippur War, which was launched 50 years ago nearly to the day; and

WHEREAS, more than 300,000 reserve soldiers were called to defend the state of Israel and Israeli Prime Minister Benjamin Netanyahu declared that Israel was at war to defend itself.

Now, Therefore, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF THOMASTON;

That the Village of Thomaston unequivocally condemns Hamas for this deplorable and unprovoked attack on Israel.

That the Village of Thomaston stands in solidarity with the State of Israel and condemns this unprovoked attack by Hamas against Israel and its citizens and supports Israel's right to defend itself and protect its citizens from indiscriminate violence and terrorism.

The Village of Thomaston unequivocally supports the right of the State of Israel to exist as a sovereign and independent nation, with the full recognition of its borders and territory.

That this resolution shall take effect immediately from and after its passage, and it is accordingly so resolved.
