## **Approval of Minutes**

## **RESOLUTION 23-88**

Upon motion of Trustee Halpern, seconded by Trustee Sherman, and unanimously approved, the following resolution was adopted:

#### Purchase of 2023 Ford F-350 Pickup Truck

The Board had previously reviewed a quotation from Hempstead Ford, dated October 16, 2023, for a 2023 F-350 Ford pickup truck pursuant to the Westchester County Contract (RFB-WC 23087) for 2023 Pickups Trucks for "On Lot" purchases, which the Village of Thomaston is authorized to use in lieu of competitive bidding.

## **RESOLUTION 23-90**

Upon motion of Mayor Weinberg, seconded by Trustee Chagrin, and unanimously approved, the following resolution was adopted:

WHEREAS, the Village of Thomaston desired to purchase a 2023 Ford F-350 pickup truck with various options from Hempstead Ford, an authorized vendor of the Westchester County Contract (RFB-WC 23087) for "On-Lot" 2023 Pickups Trucks, and

WHEREAS, the Village is authorized pursuant to law to purchase such vehicle in accordance with the terms of the Westchester County Contract, without the necessity to advertise for competitive bids for such purpose, and

WHEREAS, Hempstead Ford provided the Village of Thomaston with a quotation, pursuant to the Westchester County Contract, for an available "on-lot" vehicle which fulfilled the Village's requirements, and

WHEREAS, Hempstead Ford offered to hold this vehicle without any down payment, provides that the Village promptly issue a purchase order for said vehicle, and

WHEREAS, there being insufficient time to convene a meeting of the Board for this proposed purchase, Mayor Weinberg separately discussed this matter with each member of the Board of Trustees individually and each Trustees was in agreement that a purchase order be issued in order to have the dealer reserve the vehicle, and

WHEREAS, following such discussions, and with the understanding that the members of the Board supported the proposed purchase, Mayor Weinberg directed that the Village Administrator prepare and issue to Hempstead Ford a purchase order for such vehicle.

#### NOW THEREFORE BE IT

RESOLVED, that the Board of Trustees hereby ratifies the Mayor's action in directing the Village Administrator to prepare a purchase order on October 17, 2023, to be executed by the Superintendent of Public Works for the purchase of one (1) Ford F-350 4 x 4 crew cab pickup truck (VIN#1FT8W3BA2PED25691) including light package; 8' Western snow plow; and various options pursuant to the quotation dated October 16, 2023 (Attachment A), with pricing pursuant to Westchester County Contract RFB-WC-23087 and a total price of \$61,491.00.

#### Roof replacement at Village Hall

The Board reviewed a quotation dated October 18, 2023 from A & J Construction of NY, Inc., the authorized vendor pursuant to the Town of North Hempstead Contract TNH279-2022 – Roofing Repair and Replacement.

The Mayor informed the Board that the roof on the Village Hall and one other garage will need to be replaced in preparation for the installation of a solar voltaic system. The Village solicited proposals via existing contracts (available for use in other municipalities) in the Town of North Hempstead and Suffolk County, which contracts are available for use by the Village pursuant to General Municipal Law section 103.

#### **RESOLUTION 23-91**

Upon motion of Mayor Weinberg, seconded by Trustee Sherman, and unanimously approved, the following resolution was adopted:

RESOLVED, that pursuant to General Municipal Law section 103, the Mayor is authorized on behalf of the Village to accept the proposal dated October 18, 2023 from A & J Construction of NY, Inc., the authorized vendor pursuant to the Town of North Hempstead Contract TNH279-2022 – Roofing Repair and Replacement., for roof replacement at Village Hall and one other garage, and it is further

RESOLVED, that the Village Administrator is authorized to issue a purchase order for such public work, including work, labor, materials and installation on the same terms and conditions as applicable pursuant to Town of North Hempstead Contract TNH279-2022 – Roofing Repair and Replacement.

#### Solar Voltaic Project at Village Hall

The Board reviewed a quotation from Eldor Contracting Corporation dated October 30, 2023, the authorized vendor pursuant to the Suffolk County Contract SP-080522 – Solar Photovoltaic System - Supply, Install, and Maintenance.

The Mayor informed the Board that the Village had solicited proposals via existing contracts (available for use in other municipalities) in the Town of North Hempstead and Suffolk County, which contracts are available for use by the Village pursuant to General Municipal Law section 103.

#### **RESOLUTION 23-92**

Upon motion of Mayor Weinberg, seconded by Trustee Chagrin, and unanimously approved, the following resolution was adopted:

RESOLVED, that pursuant to General Municipal Law section 103, the Mayor is authorized on behalf of the Village to accept the proposal from Eldor Contracting Corporation dated October 30, 2023, the authorized vendor pursuant to the Suffolk County Contract SP-080522 – Solar Photovoltaic System - Supply, Install, and Maintenance, and it is further

RESOLVED, that the Village Administrator is authorized to issue a purchase order for such public work, including work, labor, materials and installation on the same terms and conditions as applicable pursuant to Suffolk County Contract SP-080522 – Solar Photovoltaic System - Supply, Install, and Maintenance.

## Road, Drainage, and Sidewalk Improvements Project (2023-01)- Emergency Purchase Order

The Board discussed milling and paving work required to be done on Highland Avenue in order to remediate a potentially dangerous condition. The Village is in receipt of an estimate from John McGowan & Sons, Inc., dated November 16, 2023, proposing to do various public work for the Village, including the milling and paving work necessary to be performed at Highland Avenue, and at other locations. The estimate for the portion of such work to be done at Highland Avenue, from the intersection with Colonial Road to the intersection with Shoreward Drive, is \$40,000.00. The Board discussed the need to proceed with, and complete this work, on an expedited basis, in the interest of public safety. The Board also discussed the time which would be required to prepare, advertise, and award a competitive bid for such work, and the need to complete the work on a timely basis before adverse weather conditions prevent the proper performance of the work. Given the willingness of the contractor to perform this work on the same terms and conditions as current apply to work being done by the same contractor under the existing publicly bid Agreement for Road, Drainage, and Sidewalk Improvements Project (2023-01), the Board concurred that it would be advisable to award the contract for such work on Highland Avenue to the same contractor, on an emergency basis, and without competitive public bidding.

#### **RESOLUTION 23-93**

Upon motion of Mayor Weinberg, seconded by Trustee Halpern, and unanimously approved, the following resolution was adopted:

WHEREAS, there is an urgent need, in the interest of public safety, for the Village to proceed with milling and paving of the portion of Highland Avenue from the intersection of Colonial Road to the intersection of Shoreward Drive, and to complete such work before adverse weather conditions interfere with the work and delay its timely completion, and

WHEREAS, the process of advertising and awarding a contract for such work based on competitive bids cannot be completed in sufficient time to undertake such work timely, to permit its completion before adverse weather conditions will interfere with, and possible delay, timely completion of such work, and

WHEREAS, the Village is in receipt of an acceptable estimate for such work from the contractor presently engaged in performing similar work elsewhere in the Village pursuant to the same terms and conditions as contained in competitively bid Agreement for Road, Drainage, and Sidewalk Improvements Project (2023-01),

#### NOW, THEREFORE, IT IS

RESOLVED, that the Board of Trustees hereby determines that there is a public safety emergency which warrants the issuance of a purchase order for milling and paving of the portion of Highland Avenue from the intersection of Colonial Road to the intersection of Shoreward Drive, without a public competitive bidding process, and it is further

RESOLVED, that the Village Administrator is authorized and directed to issue a purchase order to John McGowan & Sons, Inc. to perform such milling and paving work, on the same terms and conditions as are applicable to the work being done by such contractor under Agreement for Road, Drainage, and Sidewalk Improvements Project (2023-01, for a cost not to exceed \$40,000.00.

#### Intermunicipal Agreement with the Manhasset Lakeville Water District

Mayor Weinberg advised the Board that the Manhasset Lakeville Water District had proposed to enter into an Intermunicipal Agreement with the Village with respect to sharing costs of milling and paving work on Highland Avenue to be done by the Village, which would be of mutual benefit to the Village and the District., Counsel for the District has prepared and submitted a proposed agreement for such purpose, which has been reviewed by the Village Attorney. The Board was requested to approve such Intermunicipal Agreement.

#### **RESOLUTION 23-94**

Upon motion of Trustee Sherman, seconded by Trustee Chagrin, and unanimously approved, the following resolution was adopted:

WHEREAS, there is an urgent need for milling and paving work to be done on Highland Avenue, to remediate a potentially dangerous condition, and

WHEREAS, such milling and paving work will be done in conjunction with and in relation to work done at such location by the Manhasset Lakeville Water District, and

WHEREAS, the District has offered to share in the costs of such project, and for that purpose has proposed an Intermunicipal Agreement to be executed between the District and the Village, and

WHEREAS, it is in the best interests of the Village, and its taxpayers, for the District and Village to cooperate and share the costs of such project,

NOW, THEREFORE, BE IT

RESOLVED, that the Mayor is authorized to enter into an Intermunicipal Agreement with the Manhasset Lakeville Water District for the Village to perform, and the parties to share in the cost of, milling and paving work, to be done by or at the behest of the Village, which would be of mutual benefit to the Village and the District, such agreement to be in the form prepared by District counsel and reviewed by the Village Attorney.

## Kroll, LLC proposal for fixed asset accounting ledger for 2023/24

The Mayor informed the Board that the Village has received a proposed engagement letter from Kroll, LLC for professional services to provide an updated fixed asset accounting ledger in conjunction with the annual audit. The cost for the fixed asset accounting ledger for the FYE 2/29/24 will be \$2,100 vs. \$2,000 for FYE 2/28/23.

The Board reviewed the annual invoice for required contributions by the Village to the NYS & Local Retirement System.
