Workers Compensation Policy - Multiple Year Contract Extension Option

Mayor Weinberg informed the Board that the Village has just entered the second year of the two year contract for the Village's workers compensation policy from PERMA. PERMA has offered to extend the current contract to a third year, beginning 6/1/18. The quoted cost for year three, excluding the NYS Worker's Compensation Assessment (estimated to be \$1,140 for the 6/1/2018-6/1/2019 year), is \$21,189 (if the loss ratio is under 10%), \$21,931 (if the loss ratio is between 10%-20%), \$22,698 (if the loss ratio is between 20%-30%), \$23,833 (if the loss ratio is between 30%-40%), and \$25,144 (if the loss ratio is over 40%). Final contribution will be based on the loss experience from 6/1/2017-4/30/2018.

Tax Certiorari Settlement - Paterno v. Assessor

State and Municipal Facilities Program (SAM) Grant #6978 - Grant Disbursement Agreement

The Board reviewed the Grant Disbursement Agreement for SAM Grant #6978. The \$110,000 grant, which is administered by the Dormitory Authority of the State of New York (DASNY), is designated for road improvements (repaving) on Susquehanna Avenue, and the Belgrave section of the Village. The project was completed in 2016. Former New York State Senator, Jack Martins was the sponsor of this grant.

Replacement of Dump Truck

Speed Limits

The Board discussed reducing the speed limit to 25 mph on certain streets within the Village. Streets, or portions thereof, under consideration for reduced speed limits are Colonial Road, Grace Avenue, Schenck Avenue and Shoreward Drive.

The Board then reviewed a proposal prepared by Robert Eschbacher, P.E. for traffic engineering services to determine the placement of speed limit signs which would be required on all streets with a speed limit of 25 mph.

The Board responded to these concerns and discussed plans to add additional plantings to this island. The Mayor indicated that the Department of Public Works has and will continue to address the issues presented.

There was a discussion about the LIRR plantings on Grace Avenue.

There was also a discussion about the use of gas powered blowers and improper placement of garbage at the curbside throughout the Village.

The Mayor reported on the recent activities of the Public Works Department.
