## **APPOINTMENT OF MAYOR**

Upon motion of Trustee Noren, seconded by Trustee Sharkey and Trustee Pang, Steven Weinberg was appointed Mayor of the Village for the remainder of the term of Robert Stern, the former Mayor who resigned dated and effective September 9, 2014. Upon his election by the Board of Trustees, the Oath of Office was administered and he signed the Oath of Official Register.

Jill S Monoson, as Trustee for the vacant seat until the next the election in March.

Lawrence Greengrass as Commissioner at Large filling the position formerly held by Donald Stern who resigned effective September 10, 2014.

Ms. Monoson took the Oath of Office, signed the Official Register and took her seat on the Board of Trustees.

## **Traffic Island Beautification**

The Superintendent of Public works will solicit proposals for the re-planting and beautification of the selected Traffic Islands at Weigh Court, St. George Road, Terrace Drive, Valley View Road, Avalon Road and Brompton Road. They will be reviewed by the Board of Trustees at a subsequent meeting.

#### **Resident gift of Street Trees**

Mayor Weinberg reported that several Village residents had offered to purchase replacement Street Trees to be planted in the Village right of way. A consensus of the Board was that the gift of a tree to the village would be reviewed on a case by case basis. In addition, the resident would have to select a tree from an authorized list of approved trees as designated by the Village.

## Sign Application - Korean United Methodist Church of NY

An application to replace the existing sign with a new sign was presented to the Board by Linda Lee and Young Lee representing the Church. They requested a deviation from the presented application to increase the height of the sign. Mayor Weinberg informed them that such a variation would require an application first to the Zoning Board of Appeals and if granted than the Board would consider the application. The Church members will consult with their Board to determine which direction they wish to proceed.

## Recognition of former Mayor Bob Stern's years of service

#### **RESOLUTION 14-50**

Mayor Weinberg spoke of the many years of service and dedication by Mr. Stern to the Village of Thomaston. One of his suggestions was to dedicate the Village Hall as the Robert Stern Village Hall. After a brief discussion of various options, the following motion was offered by Mayor Weinberg, seconded by Trustee Noren and unanimously passed:

RESOLVED, that the Village Hall of Thomaston be dedicated as the Robert Stern Village Hall.
