Adoption of Minutes

RESOLUTION 14-52

Upon motion of Deputy Mayor Sharkey, seconded by Trustee Monoson, the following resolution was unanimously adopted:

RESOLVED, that the minutes of the Board of Trustees meeting held on October 20, 2014 are hereby approved and accepted as amended.

Payment of Annual Invoice NYS & Local Retirement System

RESOLUTION 14-53

Upon motion of Trustee Monoson, seconded by Deputy Mayor Sharkey the following resolution was unanimously adopted:

RESOLVED, that the Village Administrator is authorized to pay the annual invoice from the NYS & Local Retirement System by the December 15th date to take advantage of the early payment discount.

Traffic Island Beautification

The Trustees reviewed the two quotations for planting of the traffic islands at Weight Court, St. George Road, Terrace Drive, Valley View Road, Avalon Road and Brompton Road. The quotation from Simeone Landscaping/Contracting for the work was \$34,700.00 and the second quotation was from Goose Bay Landscaping Inc. for \$47,530.35.

RESOLUTION 14-54

RESOLVED, that the village accept the quotation from Simeone Landscaping/Contracting for the sum of \$34,700 and that the Superintendent of Public Works should supervise the execution of the beautification project weather permitting.
